## Year 9 Parents' and Options Evening, Wednesday 22 March 2023

I am delighted to invite you to attend our Year 9 Parents and Options Evening, on Wednesday 22 March 2023, from 4:00pm until 7:00pm.

The purpose of the evening is to ensure that the option process for your child is successful, and that you are provided with all required information to enable you to make correct choices, to support your child as they progress into Key Stage 4.

During the evening, you will have the opportunity to formally meet with your child's English, Maths and Science teachers, to discuss their progress in these subjects. All other subjects including teachers from Key Stage 4 option choices, will be available to discuss your child's current progress and to inform you of the courses available at Key Stage 4, and their subject content.

## To login and book, you will need to enter:

- Your first name and surname
- Your child's first name, surname and date of birth

Appointments will be available to book from 12:00 on 10 March 2023 until 13:00 on 22 March 2023.

The login details you enter <u>must</u> match those we have on record for you. If you are unable to log in, the most likely reason is that the details you are entering do not match what we have on our system.

Please book early to ensure you are able to meet with all teachers you need to. Along with core subject teachers there is an opportunity to book with Ms Loveridge for SEND, Ms Reeve for attendance, Mr Miller for Student Services and Miss Simperl for careers guidance. Please only book these appointments if they are necessary and you have queries related to SEND, attendance, wellbeing or careers. After you have made your appointments, you can choose to print or e-mail a confirmation.
